Western Jurisdiction United Methodist Women's Quadrennial Meeting June 1-3, 2012

Registration fee \$140 per person (postmarked by 4/15/2012). Late Registration \$165 (if postmarked after 4/15/2012). The registration fee covers the cost of the program, packet, Saturday's banquet and admittance to the Quadrennial Meeting. Meals (other than the Saturday night banquet), hotel, transportation, and parking fees are not included in the registration fee. Fees for the Hands-On-Mission trip to the Portland area food bank and any additional local tours which may be offered and guest tickets for the Saturday evening banquet are not included in the registration fee. Hotel Reservations: You must reserve your hotel room directly through the hotel. The conference hotel is the Portland Marriott Downtown Waterfront Hotel, 1401 SW Naito Parkway, Portland, Oregon 97201, (503) 226-7600. Please make your reservation on-line at <https://resweb.passkey.com/go/UnitedMethodistWomen>. Or, call 1-800-266-9432 and tell them you are attending the Western Jurisdiction United Methodist Women's Quadrennial Event. The rooms reserved for this event are a standard room with two double beds. The room rate is \$120.00 per night and includes a continental breakfast for two people. Each additional person in the room is an additional \$10.00. These rates do not include the normal applicable hotel taxes.

Our block of hotel rooms is limited so please book early. To enjoy your stay longer, the Portland Marriott Downtown Waterfront Hotel guarantees the same rates 3 days prior and 3 days after the meeting date, subject to available at the time of reservation. Deadline for hotel reservations is May 15, 2012.

Workshops, Tours and Mission Trips: There will be a workshop entitled "Going Green" on Friday, June 1 in the morning and repeated again in the afternoon. In addition, there will be a hands-on-mission field trip to the Portland area food bank on Friday afternoon, June 1. Transportation/Parking: Attendees are responsible for their own transportation to and from the airport. There are a variety of shuttle services from the Portland International Airport including Blue Star Shuttle www.bluestarbus.com, PDX Shuttle www.pdxshuttleportland.com, as well as taxis. Shared ride shuttles cost approximately \$14 one way. A taxicab is about \$30. For a full listing of transportation options available, just go to Google and enter "Portland, Oregon Airport shuttle services" and you will have a good selection from which to choose.

Hotel parking fees: The hotel has discounted valet parking fees by 50% for this event. In addition, there is parking available in a public parking garage behind the hotel for \$12/day.

Cancellation Policy: Upon receipt of written notice and request for a refund prior to May 25, 2012, the quadrennial meeting registration fee, minus a \$50 cancellation may be refunded by the registrar or upon consideration by the Western Jurisdiction Leadership Team. Registrations may be transferred without penalty, to another attendee who is not already registered, provided written request for transfer of registration fee is received by the registrar prior to the event.
